

**NOTICE OF VARIATION OF OFF STREET PARKING CHARGES  
THE CHORLEY BOROUGH COUNCIL(OFF-STREET PARKING PLACES,  
CHORLEY) (CONSOLIDATION AND AMENDMENT ORDER 2008)  
(Notice of Variation No. 4 2017)**

NOTICE is hereby given that Chorley Borough Council ("the Council") will on 21<sup>st</sup> August 2017 under Sections 35(1) and 35(3) and 35C of the Road Traffic Regulation Act 1984 (as amended) and Regulation 25 of the Local Authorities' Traffic Regulation Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers revise the charges for Off-Street Parking Places.

1. This Order shall come into force from 21<sup>st</sup> August 2017. The Council will post notices at each Parking Place set out in the Schedules below stating the revised car parking charges after the date that the notice of making is first advertised in accordance with Regulation 17 of and Schedule 1 to the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and may be cited as the "Chorley Borough Council (Off-Street Parking Places, Chorley) (Consolidation and Amendment Order 2008) (Variation No.4 2017)."
2. In this Order the term 'the Consolidation Order' means The Chorley Borough Council (Off-Street Parking Places, Chorley) (Consolidation And Amendment Order 2008) save as expressly varied as aforesaid shall continue in full force and effect.
3. In this Order the term 'Variation Order No. 1' means The Chorley Borough Council (Off Street Parking Places, Chorley) (Variation) Order 2012 save as expressly varied as aforesaid shall continue in full force and effect.
4. In this Order the term 'Variation Order No. 2' means The Chorley Borough Council (Off Street Parking Places, Chorley) (Variation No.2) Order 2016 save as expressly varied as aforesaid shall continue in full force and effect.
5. In this Order the term 'Variation Order No.3' means The Chorley Borough Council (Off Street Parking Places, Chorley) (Variation No.3) Order 2017 save as expressly varied as aforesaid shall continue in full force and effect.
6. When this Order comes into force pursuant to paragraph 1 above:
  - (a) The Consolidation Order is varied by deletion of reference to Back Mount in Schedule 3.
  - (b) Back Mount Car Park shall be varied from Short Stay Saturday only to Long Stay Monday – Sunday as shown in the Schedule to this Order.
  - (c) Variation No.3 is varied by deletion of reference to Time of Arrival Tickets in Schedules 2 and 3 and replaced with the following:-  
'Customers taking advantage of the free parking period at any long stay or short stay car park may only park for the specified maximum period and must display a Time of Arrival Ticket.'
  - (d) The Consolidation Order is amended by varying the limits of the Parking Place at Hollinshead Car Park as shown on the map annexed hereto which can be inspected at the Town Hall during normal business hours
  - (e) Hollinshead Car Park shall continue to be a Parking Place for the purposes of the Consolidation Order.

**SCHEDULE OF PARKING PLACES AND VARIATION – BACK MOUNT CAR PARK**

Long Stay: free for up to 3 hours or a charge for up to 4 hours or all day (8am - 5pm).  
Free parking after 5pm Monday – Friday, after 1pm on Saturdays and all day Sunday and Bank Holidays.

Please note the following:-

- (a) Consecutive ticketing will be prohibited
- (b) Tickets are not transferable from car park to car park or vehicle to vehicle
- (c) No return to the same car park within 2 hours

For customers who are taking advantage of the free parking:

- (a) A 'time of arrival' ticket must be obtained where required
- (b) The 'time of arrival' ticket must be displayed where required
- (c) Free parking periods cannot be used to extend stays. If customers wish to park for a duration which exceeds the free period of parking they must purchase a Parking Ticket.
