

What if I don't have a permit?

If you don't have an inert waste permit, or if you have more inert waste than the permit provides for, you have an **option to pay** at the HWRC.

The charge in these circumstances is £3.50 per bag or item.

For inert waste delivered in trailers the following charges apply:

Trailers up to 1 metre in length = £17.50

Trailers up to 2 metres in length = £35

Trailers up to 3 metres in length = £52.50

Open backed vehicles (such as pickups) will be charged as above dependent upon size of carrying area.

If your waste is presented by any other means (including where the capacity has been artificially increased) the site attendant will make an assessment of the equivalent bagged amount and subsequent charge. **Payment will be taken on site by credit or debit card only.** Payment by cash or cheque will not be accepted.

Construction and Demolition (inert) waste

You need a permit to deposit construction and demolition (inert) waste free of charge at our Household Waste Recycling Centres.

We have changed the way you recycle Construction and Demolition (inert) waste at the Household Waste Recycling Centres (HWRCs) in Lancashire.

To deliver inert waste free of charge to a HWRC householders need to obtain a free **inert waste permit**.

What can I deliver with my inert waste permit?

Your FREE inert waste permit will allow you to deliver 10 bags or single items (such as a sink or toilet) of inert waste each calendar year.

The maximum bag dimensions that we will accept as one bag is 600 x 900 mm.

If your waste is presented by any other means (including where the capacity has been artificially increased) the site attendant will make an assessment of the equivalent bagged amount.

How can I apply for an inert waste permit?

You can request a FREE inert waste permit online by registering with Lancashire County Online via our website www.lancashire.gov.uk/waste or by calling 0300 123 6781.

What types of waste do I need an inert waste permit for?

You need an inert waste permit to deliver any of the following waste types free of charge:

Breeze Blocks	Plaster*
Bricks	Plasterboard*
Ceramics (Baths, Bidet, Shower Tray, Sink, Tiles, Toilet)	Rubble
Clay	Sand (Sharp)
Concrete	Slates
Flagstones/Paving	Soil
Slabs	Stones
Gravel	Tarmac
Hardcore	Tiles (Floor/Roof/Wall)
	Turf

* These waste types should be presented separately and deposited in the plaster and plasterboard container.

You do not need a permit to deposit any other waste type.
