

THE CHORLEY BOROUGH COUNCIL

(OFF-STREET PARKING PLACES, CHORLEY) VARIATION ORDER 2025

The Council of the Borough of Chorley (hereinafter referred to as “the Council”) in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”), the Traffic Management Act 2004 and of all other enabling powers, with the consent of Lancashire County Council in accordance with section 39(3) of the Act and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

Title

1. This Order may be cited as the Chorley Borough Council (Off-Street Parking Places, Chorley) Variation Order 2025.

Commencement and Effect

2. This Order shall come into operation on the twentieth day of August 2025. Save as varied by this Order the Chorley Borough Council (Off-Street Parking Places, Chorley) Consolidation Order 2008 (“the 2008 Order”) as subsequently varied will continue to apply. With effect from the twentieth day of August 2025 the 2008 Order (as subsequently varied) shall have effect with the following variations:

A) **Amendment 1:** Hallgate, Ackhurst Lodge and Yarrow Park car parks to be introduced.

Charges apply Monday to Sunday 8am to 5pm

B) **Amendment 2:** Sandham Street car park to become a permit only car park – eligible properties only.

C) **Amendment 3:** that Arley Street car park is added to Schedule 2 as set out below:

Charges apply Monday to Friday 8am to 5pm, 9am to 1pm Saturday

Up to 4 hours	240	£2.00

Please note the following:-

- (a) Consecutive ticketing will be prohibited
- (b) Tickets are not transferable from car park to car park or vehicle to vehicle
- (c) The Maximum Stay at each car park is set out in the Schedules above
- (d) No return to the same car park within 2 hours

For customers who are taking advantage of the free parking:

- (a) A 'time of arrival' ticket must be obtained where required
- (b) The 'time of arrival' ticket must be displayed where required
- (c) Free parking periods cannot be used to extend stays. If customers wish to park for a duration which exceeds the free period of parking they must purchase a Parking Ticket.
