Thank you for sending through the additional representation.

The appellant notes that the email was sent on Monday 1<sup>st</sup> April and references an issue which arose earlier that same evening with a bus failing to turn up at the bus stop on Willow Road (the 112 route). We would point out that Monday 1<sup>st</sup> April was a bank holiday (Easter Monday). The County Council's website promotes that bus timetables operate to a Sunday timetable on bank holidays; the current 112 timetable does not provide any Sunday service. As such and in accordance with the advertised timetable, it would have been expected for there not to be any buses operating from the Willow Road bus stop on Monday 1<sup>st</sup> April.
